ReFocus on Better Environmental Outcomes

Learn how Iowa's Clean Water State Revolving Fund invested in the Soil and Water Outcomes Fund, a partnership between ReHarvest Partners, subsidiary of Quantified Ventures, and AgOutcomes, a subsidiary of the Iowa Soybean Association, is incentivizing farmers to implement new conservation practices that improve water quality and sequester greenhouse gases.
